

Official Rules

"New Year, New World Mini-Sweepstakes" Official Rules (the "Rules"): No purchase necessary to enter or win.

1. Contest description: " New Year, New World Mini-Sweepstakes " (the "Contest") will begin on January 5, 2016 and conclude on January 22, 2016 (the "Contest Period"). The Contest is sponsored by the Sentai Filmworks, LLC. (the " Sponsor").

2. Eligibility: The Contest is open to legal residents of the continental United States who are at least the age of eighteen (18) as of the first day of the Contest Period. Notwithstanding the above, the Contest is not open to individuals associated with the Contest, including the employees, agents or representatives of the Sponsor (including its respective divisions, subsidiaries, affiliates and advertising or promotional agencies) and suppliers providing prizes or other materials or services in connection with this Contest (collectively, the "Excluded Individuals"). This Contest is also not open to the immediate family members (spouse and parents, siblings and children and their respective spouses, regardless of where they reside) of the Excluded Individuals, and all other persons with whom the Excluded Individuals reside, whether or not related, and any persons who have won a prize in a Sponsored by the Sponsor within the last year.

Take the quiz within The Contest submission period between January 5, 2016, 9:00 A.M. CST to January 22, 2016, 11:59 P.M. CST. Share the quiz result on Twitter, or sign up for Sentai Filmwork's eNews via the form embedded on the quiz during the Contest submission period. Only one (1) entry per is required. Additional entries are void. Winners will be announced on January 26, 2016. The Sponsor will not accept entries by phone, mail, email, fax or any other method not specifically permitted herein unless deemed allowably due to computer errors by the Sentai Filmworks, LLC. All entries must be received during the Contest Period.

4. Competition Winner: Five (5) winners will be selected at random via Twitter hashtags and eNews signups accrued during the submission period. The winner selection will be conducted by Sponsor. In order to be declared a winner by the Contest judges, a potential winner must be in compliance with these Rules and, in particular, the following:

4.1 A representative of the Sponsor must be able to reach the potential winner independently by email informing him/her that he/she is the potential winner subject to meeting all the requirements of these Rules. The potential winner is required to respond to the notification within a 48 hour period. If the potential winner is unreachable during this time frame, such potential winner forfeits his/her prize and another potential winner shall be selected from the remaining eligible entries and the same procedure noted herein shall be followed. Return of e-mail prize notification as undeliverable may result in disqualification and alternate selection/potential winner may be drawn.

4.2 If a potential or declared winner is not in compliance with these Rules, the Contest judges reserve the right to disqualify such entrant from the Contest and select further entrants from the remaining eligible finalist entries until a winner is finally declared. The Sponsor reserves the right not to award the Grand Prize if he/she is unable to declare a potential winner a declared winner within a reasonable time frame, which shall be subject to the Sponsor's sole discretion Entrants

will not be individually contacted, except for the potential winner(s), who will be contacted by email.

5. Odds of winning: Odds of winning the prize depends on the number of eligible entries received during the Contest Period.

6. Prize. Five (5) random winners will receive: One (1) "Sentai Noticed Me" button; One (1) surprise prize valued at \$69.99 MSRP or less. Prize is awarded "as is" with no warranty or guarantee, either express or implied. All prize details are at Sponsor's sole discretion. Prize must be accepted as awarded and may not be transferred or substituted or converted to cash, except as may be provided for in these rules. If you are a declared winner, you will be contacted via email as provided in your entry form. The potential winner will be required to furnish proof of official government photo identification such as a driver's license or passport. The arrangement for prize delivery will be made by the Contest judges.

7. Publicity: By entering the Contest, you consent to the Sponsor's and its designees' use of your name, image and likeness for any publicity and advertising purposes, in any and all media, now or hereafter devised, worldwide in perpetuity, without additional notification, permission or compensation, except where prohibited by law.

8. The decisions of the Sponsor and the Contest judges are final and binding in all matters. In the event of a conflict between the rules and any instructions or interpretation of these Rules given by an employee of the Sponsor regarding a Contest, these Rules shall prevail. In the event of any discrepancy or inconsistency between the terms and conditions of the Rules and disclosures or other statements contained in any Contest-related materials, including but not limited to the Contest entry form, or point of sale, print or online advertising, the terms and conditions of the Rules shall prevail, govern and control.

9. By entering this Contest, entrants agree to be bound by the Rules. By participating in the Contest, each entrant agrees to be bound by the Rules, which will be posted at the Contest Website. The Rules may also be requested by sending a self-addressed stamped envelope to the Sponsor.

10. All entries become the sole property of, and are subject to verification by the Sponsor and in no case shall be acknowledged or returned to sender.

11. Any attempt to tamper with the entry process, interfere with these Rules, deliberately damage any website or undermine the administration, security or legitimate operation of the Contest, is a violation of criminal and civil laws, and the Sponsor reserves the right to seek damages and/or other relief (including attorneys' fees) from all persons responsible for such acts to the fullest extent permitted by law, which may include banning or disqualifying entrants from this and future Contest conducted by Sponsor. In its sole determination, the Sponsor may disqualify any person who acts in violation of these Rules, or acts in any manner to threaten or abuse or harass any person and void all associated entries.

12. Entries generated by script, macro, robotic, programmed, or any other automated means or by any means which subvert the entry process are prohibited and will be disqualified. Any individual who attempts or otherwise encourages, directly or indirectly, the entry of multiple or false contact information under multiple identities, or uses any device or artifice to enter or encourage, directly or indirectly, multiple or false entries, as determined by the Sponsor, will be disqualified and all associated entries will be void.

The Sponsor and the Released Parties are not responsible for any printing/production errors.

By entering the Contest, each entrant releases and holds harmless the Released Parties from any damage, loss or liability, suffered, including personal injury or property damage, as a result of or arising, in whole or in part, directly or indirectly, from the entrant's participation in the Contest or the acceptance and use of the prize (including any travel or activity related thereto).

18. The Contest is void where prohibited by law and is subject to all applicable federal, state, and local laws and regulations, in the US, as applicable.

19. The invalidity or unenforceability of any provision of these Rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Rules shall otherwise remain in effect and shall be construed in accordance with the terms as if the invalid or illegal provision were not contained herein. 21. In the event of any dispute, all parties agree that the judgment and determination of the Sponsor or its representatives will be final and binding in the awarding of the Prize Package.
